Mona Carol Garrett Vice, 66, of Carlisle, wife of Mark Allen Vice, gained her heavenly wings on May 6th, 2025 at the University of Kentucky Hospital.

A Nicholas County native, Mona was born on September 13th, 1958. She was a 1976 graduate of Nicholas County High School and attended college at Eastern Kentucky University. Mona spent many years as an Information System Support Supervisor with Appalachian Regional Healthcare and received many certificates indicating advanced knowledge in her field. She was a long-time dedicated Nicholas County Board of Education member for 30 years, serving as Chairperson for 28 of those years.
